Module IV 2024 Additional guarantee conditions for extended guarantees

This module is part of the Guarantee Supplement referred to in the applicable SWK regulation.

Under this module the Contractor may offer extended guarantee periods to the Buyer for several structural components and technical systems. The Contractor may determine what extended guarantee periods apply and to what structural components they apply. One condition is that the guarantee period may not be shorter than the guarantee period offered in Module I and may not be longer than the guarantee periods specified in the table in Article 1 below.

If Module I and Module IV mention the same component, the guarantee period specified in Module IV applies to such component. The guarantee periods mentioned in Module I apply to components that are mentioned only in Module I. The guarantee exclusions of Module I apply in full.

If extended guarantee periods are offered to the Buyer, the Contractor must submit a specification of those extended guarantee periods to SWK when it submits the plan.

Article 2 Additional conditions

The following additional conditions apply to extended guarantee periods in respect of the Defects Warranty:

- The extended guarantee periods are applied only if the Defects Warranty is given to a party that is not a consumer (non-consumer party).
- The non-consumer party must have a 10-year Insurer-approved maintenance plan in place for the plan to which the extended guarantee periods apply.
- The extended guarantee periods apply only if the Contractor has the required product guarantees and maintenance specifications from subcontractors and/or suppliers at its disposal.
